Description:

The course introduces the Israeli political system, its various protagonists, their interests and motivation. The students will be familiarized with the major issues and conflicts which have occupied the Israeli political agenda since its inception until today. To facilitate the understanding of dynamics and developments of the Israeli political arena, the political culture will be analyzed to supply the relevant context for one of the busiest and most volatile political structures in the world today. Ultimately, we will use the Israeli political system as a compass and a reflection of the intricacies and idiosyncrasies of the Israeli society at 60.

Course requirements

Essential pre-requisites are curiosity, persistence and constructive criticism. Students are expected to arrive to class on time, having read the material due that day, and equip themselves with ample questions and comments. In addition to the reading material, students are advised to read newspaper and magazine articles and to keep up with radio and TV news about Israel due to the fluid and ever-changing nature of our subject matter. It is especially warranted to read news items and articles from the Jerusalem Post (http://www.jpost.com) which will add relevance and immediacy to class discussions.

There are two exams, a midterm and a final, which are non-cumulative. In addition, each student will be asked to choose a JP article according to the class topics and prepare a 15 minutes presentation of its main points.
